ESG Gaming: Strategic review

As usual, I have produced and published this strategic review before our board meeting on <u>Tuesday</u>, <u>07 November, at 1100</u>. This review provides a top-level snapshot of activities undertaken in summary form, which can be elaborated upon, at the board meeting.

Founder & NED payments.

The highest-paid director (L Willows) received a remuneration of £89,993 Gross for 01 August 2022 – 31 July 2023 and is employed full-time within ESG Gaming. The board agreed that the maximum salary for this post is £125,000, which I now propose to be fixed until 31 July 2025. Between 14 August 2021 - 31 July 2022, this post holder drew down a salary of £900 Gross.

Other directors at ESG Gaming drew honorariums as follows: £4,500 Gross (C Jones) / £6,000 Gross (S Cooke) and £500 Gross (P Romero). These were agreed honorarium payments for the role of Non-Executive Directors (NEDs). The board have decided that NEDs can draw down £250pcm, with additional payments made for work over and above their fiduciary roles (i.e. the agreed 10% fee to help with fundraising). Between 14 August 2021 – 31 July 2022, these directors did not draw any honorarium.

ACTION: (i) The Board are asked to re-confirm these arrangements and (ii) extend the salary cap of the Founder, which is proposed to July 2025 (i.e. propose no salary review for 24 months).

Investors in People (IIP) accreditation.



Collective Four.

A number of projects were proposed for a collective four donation. All these have been turned down due to the collective four commitment to GambleAware.

GambleAware – System Stabilisation Fund.

ESG Gaming has committed to full transparency and publishing all funding proposals to GambleAware / Levy Board and Statutory sources. We have also committed to publishing all monitoring and financial returns to these bodies too. Timeline of our SSF proposal:

As of 01 November, we do not have a decision on the amended proposal. We are also looking to apply to the SSF once the new round re-opens w/c 06 November. I intend to upload all this communication to our website in the coming couple of weeks, given the commitment to transparency. I will do this once we have feedback on our amended proposal.
